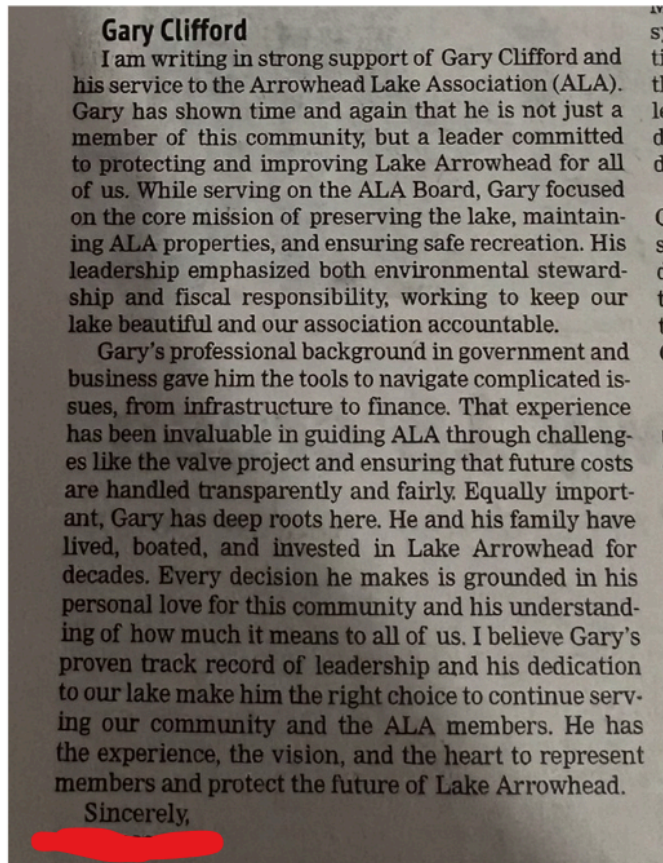
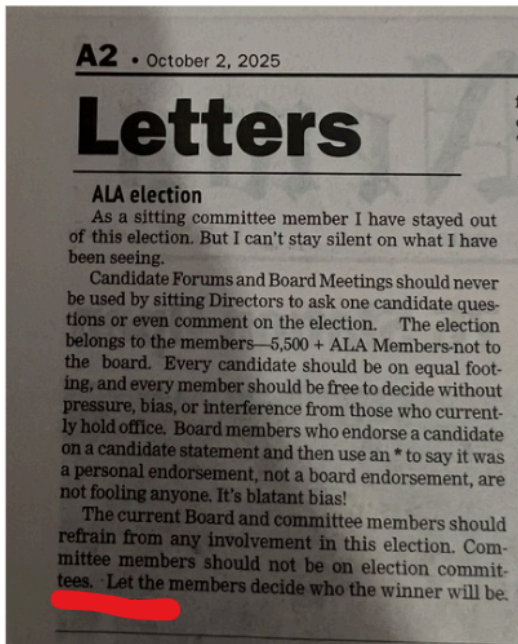

In April of 2024 this ALA board decided to contract JCB to remedy our valve outlet works deficiencies. Then on August 29, 2024 at the California department of water resources, divisions of safety of dams headquarters in Sacramento, DSOD stated that since **THE SEVEN BOARD MEMBERS OF ALA HAD NOT MADE ANY PROGRESS** in remedying the outlet work system and that the current system was non operational, a system replacement would be needed and that the new system would have to meet current lake level draw down standards of 10% lake elevation draw down in seven days and 100% lake elevation draw down in 90 days.

The ALA board has a "BIG DAM" Valve issue! Gary Clifford will involve all parties responsible and make sure all parties pay and will make sure ALA members don't get stuck with the whole bill.
