- 5. 2018 volunteer services: developed design renderings and color schemes for the **Ralph Wagoner Building and Lobby renovation**. developed design renderings and estimates for the **Burnt Mill Beach Club renovation**.
- 6. 2018 supported the community to remove the commercial air traffic from Lake Arrowhead, attending meetings and FAA presentations, submitting letters.
- 7. Boat owner and Dock Captain Dam1 Membership Association 1985-1994, 2012-to present.
- 8. Serve on the Board for the Lake Arrowhead country Club as Secretary, Chair of the Facilities Committee, , coordinated the Reserve Study Report and implementation, serve on the Finance Committee.
