Dock/Slip rentals are not authorized for any commercial or nonmember use.

The ALA member, lessee, and ALA member, lessor, of the rented Dock/Slip will indemnify and hold harmless the Arrowhead Lake Association. The ALA member, lessee, and ALA member, lessor, owners and renters of the Dock/Slip, are responsible for the actions, conduct and safety of any person who is party to a **Dock/Slip Rental Agreement**.

An administration fee of \$50.00 is payable at the time of application for a **Dock/Slip Rental Agreement.**
